**Electoral College:** The Electoral College in respect of the aforementioned election shall comprise of all alumni members of CLCAA.

**Nomination Process:** Nomination for election to the Governing Body of CLCAA shall be required to be proposed and seconded by a member of CLCAA.

**Election Process:** In case an election to one or more of the aforementioned posts is needed, a tally of votes polled by each candidate in respect of that particular post, will be prepared. From this tally, vacancies will be filled up based upon candidates who poll the maximum number of votes. In case of a tie for any of the posts, the Returning Officer shall choose an appropriate method to resolve the issue.
